From Your President:

There are multiple reasons to stay connected to your former in-service local. Among those reasons are the changes that are occurring regarding retiree health insurance. Some changes have been made because in-service members have been convinced that because they are young and healthy, the money allocated for health insurance costs would be better spent keeping the cost of the plan low and giving the money to the member to use for services. While that may appear to be fiscally prudent for our younger members, as we age, that model may not meet the medical needs of retirees and could significantly impact older members whose pensions and social security have not kept pace with inflation and increased medical costs. Newer retirees may not realize that the insurance

they currently have will be secondary once they reach the age of 65+, when they will be required to enroll in and pay for Medicare as well as the plan under which they retired, which becomes their supplemental plan

We have witnessed that over the years as more people leave the plans we have known for decades; the plans no longer have enough participants and will not be offered in the future. We may then be forced into these new high deductible models which have more oversight on expensive procedures and, ultimately, additional out-of-pocket costs.

Another disturbing trend is districts switching to plans that no longer recognize the providers with whom we have formed a relationship over decades. The newer plans may deem your provider as being "out of network" resulting in that provider not being covered for a procedure. This may include physicians, specialists, and hospital groups. Suddenly, you are asked to find a new provider or specialist that may or may not be participating with your new network.

Those of us who were active in our local governance structures were familiar with language as it was added to newly negotiated contracts. We added protections and benefits through the negotiation process that some of our newer members may not understand or recognize as important. Having a connection to your local in an advisory capacity can be the difference between losing an important piece of language and communicating the importance of that language to all members. Do you have language that requires annual meetings between the district and members of the negotiating team when changes are proposed regarding health insurance? Disregarding that provision could result in changes in plans in which members of the bargaining unit have had no input on the changes and the impact of those changes. A newer member may not understand the importance of that provision, but we remember why that provision was included.

I urge you to stay connected with your former local and offer input when major changes are proposed that could impact the contracts that were negotiated in the past. When Retiree Council 10 meets each month, we hear reports from locals where our members formerly worked. These reports keep us updated on the direction many of the in-service locals are moving in and give the rest of us an idea of the current trends. Currently we have representatives from Albany, Averill Park, Berlin, Burnt Hills-Ballston Lake, Capital Region BOCES, East Greenbush, Guilderland, Hartford, Ravena-Coeymans-Selkirk, Schodack, Shenendehowa, Troy, Washington Academy, and WSWHE BOCES. If you don't see your local represented, that means we are not getting timely updates on what is happening in your local. Please consider joining us at a future meeting to share any concerns you may have. We meet in Latham in the Capital District Regional Office at NYSUT headquarters on the third Tuesday of the month. Regular board meetings generally last 90 minutes, followed by lunch, where we can connect with other RC 10 members and talk about how we are navigating retirement.

RC 10 continues taking on new volunteer opportunities that help us to connect and remain visible in our communities. Maybe one of those organizations is what you have been looking for to stay busy. Reach out to anyone you recognize as an active member and ask any questions you may have or contact me.

Celebrate retirement in September by joining us on gorgeous waterfall hikes and informative and tasty winery tours of the Finger Lakes. Yankee Trails will provide round trip transportation with hotel accommodations at Lakefront Hotel in Geneva, located right on the shore of Seneca Lake. WEDNESDAY, OCTOBER 9, GILDED AGE ARCHITECTURAL TOUR OF HISTORIC DOWNTOWN TROY. While seeing the history of the City of Troy and its architecture, participants will understand why the downtown historic district became a popular spot for filming. During the tour, locations from Seasons 1 and 2 of the Gilded Age will be highlighted as well as some fun background stories and adventures the tour guide had with the film crews. There will be audio receivers, so everyone will be able to hear the tour guide. This 1.5 mile tour starts at 10:30 at the Hart Cluett Museum and ends at the Museum. While the terrain is mainly flat, there is a slight rise as you go from Division to Congress. There are slate sidewalks and uneven pavement, so we encourage those people who use a cane to bring it. NYSUT REPRESENTATIVE ASSEMBLY

Members make their voices heard by electing local delegates who represent them at NYSUT's annual convention, the Representative Assembly. The RA is the union's highest policy-making body, except for a membership referendum. All NYSUT members are welcome to attend the annual Representative Assembly, but only duly elected and reported delegates may debate and vote on proposed resolutions and other business that might be brought before the Representative Assembly. Representing RC 10 this year in New York City on May 3 were Cliff Brosnan, Colleen Condolora and Bonita Maxon. As delegates, they attend Committee meetings ahead of the resolutions to decide which ones are brought to the floor of the convention.

On Friday, many NYSUT services and benefits were on display. During the two days there were many speakers including, Governor Kathy Hochul, Senator Chuck Schumer, NYS Comptroller Tom DiNapoli, and Randi Weingarten. But the most inspiring speaker was NY Attorney General Letitia James. She had the group chanting "We will not go back."

President Melinda Person spoke about legislative wins and talked about the Pipeline Project, funded by Vote-Cope, which supports educators that run for office. She also stated that since 2020 Vote Cope has had a down trend, BUT in 2023 contributions increased to \$11,356,316. A motion was passed for Eric Iberger to remain on the board of the NYS Teachers Retirement System.
