#### President's Message

Dear Fellow Retirees:

What an interesting "Winter" it's been. I think I used my snow blower once all "Winter." I really can't and shouldn't complain. It's just been different...maybe our new normal? Anyway as I compose this letter to you I'm hoping you are in good health and in good spirits.

Since our last RC 11 Steering Committee meeting held on Monday January 28th things have been clicking ahead politically. I recently attended the NYSUT Committee of 100 Lobby Day in Albany – March 4th and 5th. There were a little over 500 NYSUT members involved this time (both "in-service" or "active" and "retiree" participants). My group was scheduled to meet with Assembly member Donna Lupardo and Senator Lea Webb. Donna Lupardo was able to meet with us in person. Lea Webb was heading off to a committee working on the State Budget so we met with her Chief of Staff.

Issues we discussed with both individuals were: a) Reject Foundation Aid Cuts having them advocate for full funding within the foundation aid formula; b) Fixing Tiers 5 and 6 by Co-sponsoring Assembly Bill - A9133 (Pheffer and Amato) and Senate Bill - S8490 (Jackson). We (NYSUT) are encouraging legislation that would reduce the final average salary calculation from five to three years for Tier 6 members, which would increase their pension earnings and offer parity with Tier 4 (you can learn more about this issue by visiting FixTier6.org); c) Community Schools - encouraging our legislators to support legislation advocating for the expansion of Community Schools which provide more support for student success; d) Increasing BOCES funding. The current BOCES Aid cap was established in 1992 and hasn't been updated since; e) Reforming IDAS (Industrial Development Agencies) which currently provide tax abatements to industries to build within a community but then waive school taxes. There are currently bills before the State Legislature that would prohibit IDAs from waving school taxes; and f) Supporting SUNY and CUNY - calling for our legislators to support the "New Deal For Higher Education." This would include increasing funding for more full-time faculty, better adjunct pay, more support for SUNY hospitals and increasing funding for student mental health services (you can learn a lot more about this issue by visiting PublicSchoolsUniteUs.org/NewDeal).

Donna Lupardo assured us that she is all in on every one of the issues we presented to her. She is well aware of the problems facing Public Education and is very supportive. Lea Webb's Chief of Staff took copious notes for Lea as we met with her and assured us that (in her words) – "What I can tell you is everything we are seeing currently within both houses of the legislature looks very good for the future of Public Education in the State of New York."

I've attended many Committee of 100s over the years and this was by far one of the better ones. Positive communications, no negative budget talk, everything seemed like we might actually see some good things in the future of Public Education...but....it's still early and it's all politics involved so we shall see. Let's keep our fingers crossed that all goes well in Albany. Hope Springs Eternal.

- Prices for certain items should see a decrease in 2024. This includes gas prices, airline tickets, home heating oil, cars, and grocery store prices. This is due to prices having been high and now declining. (AARP Bulletin, 1/11/24).
- After you file your Federal Income taxes for 2023, you may track your refund on the app, IRS2Go.com. You will need your Social Security number, filing status, and the exact amount of the refund expected. (AARP Bulletin, 1/3/24).
- New Medicare rules allow for mental health counselors, including addiction specialists, to now join Medicare and enroll as eligible providers as of January 1, 2024. (AARP Bulletin, 12/14/23).
- The four most common pain relievers are Ibuprofen/Naproxen, Acetaminophen, Aspirin, Topical pain relievers. All come with side effects that need to be considered before using these products. (AARP Bulletin, 2/22/24).
