From The Desk of the President **Patrick McCarthy**



Dear Colleagues,

From your Board of Directors, & myself, it is our sincere wish that this newsletter finds you in good health & able to get outside to enjoy the last beautiful days of spring in the Mid-Hudson region.

The Board of Directors have participated in the Committee of 100 (NYSUT's annual lobbying effort in Albany), retiree and in-service election district meetings, and the 2024 NYSUT Representative Assembly. The RA sets the legislative priorities for the coming year for NYSUT. This year delegates from across NYS considered over 60 proposed resolutions in both committee meetings & on the floor during the RA General Sessions. Several of the resolutions being considered were "signed on" supported by RC #13. They address issues such as retiree health insurance, monitoring Medicare Advantage programs, & book banning. The Board thanks everyone who took the time to voice their support in this year's budget talks.

Your phone calls, attendance at rallies, & Committee of 100 meet

ings, letters and over 65,000 email actions from our Member Action Center (MAC) paid off! The final budget rejected the devastating proposed cuts through the elimination of save-harmless and restores most of the money that schools would have lost under the executive budget proposal. Your efforts resulted in over \$430 million more in funding which will go into our schools.

The plan to close SUNY Downstate Hospital was rejected. Over \$100 million more in operating aid and \$100 million more in capital aid for SUNY and CUNY was provided which is a step in the Viewing our website will ensure right direction for higher education in our state. We scored our biggest win for pension reform in 20 years by lowering the Final Average Salary calculation period from 5 to 3 years for Tier 6 members. This will result, on average, in larger pension checks upon retirement which is about \$100,000 more in additional retirement earnings.

These accomplishments as well as many others, are a result of the "**collective**" voice of our members, demonstrating once again, "In unity there is strength." Together we can do so much! One of the best ways to demonstrate

your support for all of our initiatives is to contribute to **VOTE-COPE**, our Union's voluntary political action fund. This will provide much needed dollars for pension, social security and Medicare protection and gives support to candidates who, regardless of political affiliation, share our ideals & advocate for public education.

In closing, I once again urge you to check RC #13's website (scan **QR code**) for updated information on events, webinars and other opportunities to engage with fellow retirees. Since many of the activities are seasonal venues. details are not finalized until they open. The Social Committee is looking to provide a variety of activities this summer & fall. you are not missing out on any of our events. I am confident you will find something to your liking.
