While most of us would like our property taxes to take less of bite, New York State income taxes on our pension income is relatively reasonable.

### New York State Tax on Retirement Income

During the process of surveying people on what senior's think is needed in the NYS Master Plan on Aging, there appears to be confusion about NYS tax on Retirement income. The fact is that New York State offers relief of state taxes for retirement income that is equal to or better than a lot of states in the Country.

There are no taxes on Social Security income in New York State. There are twelve states (Colorado, Connecticut, Kansas, Minnesota, Missouri, Montana, Nebraska, New Mexico, Rhode Island, Utah, Vermont and West Virginia) that tax either all or part of your Social Security income.

Fourteen States exempt income taxes on pensions (Alaska,

Florida, Nevada, South Dakota, Tennessee, Texas, Washington State, Wyoming, New Hampshire, Alabama, Illinois, Hawaii, Mississippi and Pennsylvania**). New York does not tax pension income from our State or Federal Pensions at all and allows for up to \$20,000 tax-exempt income from other pensions, like 401K's or 403B's.** 

There are eight states with no State income tax.

(In summary, our NYS Pension and Social Security income are not taxed at all by NYS, and the first \$20,000 of income from 403b and 401k accounts, such as income to satisfy Required Minimum Distributions, is not taxed.)

Dear Brothers & Sisters:

Years ago, when I was teaching about the civil rights conflict during the Era of Jim Crow, I often cited the words from Booker T. Washington's Atlanta Exposition Address in which he reminded African-Americans to "cast down their bucket where they are," as he urged them to remain in the South during their struggle where their work and dedication were well known and that economic rewards would soon follow.

Given the inequality of Jim Crow segregation amidst constant threats of violence, lynching, and ever-increasing voter restrictions, Washington was attempting to calm racial fears and bring about progress through job training for the present and future.

#### Speaker Johnson Leads Battle Toward Medicare and Social Security Cuts

House Speaker Mike Johnson (R-LA) and senior U.S. senators are following through on their threat to create a so-called "debt commission" that would come up with schemes to slash Social Security and Medicare benefits Americans have earned.

The effort faces steep opposition from President Joe Biden...

Johnson reiterated his support for a commission during his first speech as Speaker, and the threat became more serious when Senators Mitt Romney (R-UT) and Joe Manchin (D-WV) introduced the bipartisan Fiscal Stability Act, S. 3262.

"These commissions always start with the false premise that Social Security contributes to the national debt, and that Social Security and Medicare should be cut," said Robert Roach, Jr., President of the Alliance. "The idea of strengthening Social Security by making the wealthiest Americans pay their fair share and increasing benefits is never considered. To quote Rep. John Larson (D-CT) on the expansion of benefits, 'The last time the program was addressed in a significant manner, Tip O'Neill was Speaker and Ronald Reagan was President.'
