On February 13, Tom Suozzi, NYSUT's endorsed candidate to replace disgraced congressman George Santos, handily won the special election for New York's 3rd Congressional district, which contains most of the communities represented by our members. That victory wouldn't have happened without the very active participation of Long Island's organized labor community and, frankly, without the dedication and hard work of NYSUT members, particularly retirees. Our members made over 23,000 phone calls, knocked on over 7,000 doors and sent over 34,000 text messages. The hard work paid off as our candidate took over 54% of the votes. #### **ELECTION DISTRICT 52 MEETING IN ALBANY UPDATE**

Susan Carlough and Ken Ulric represented RC 17 at an Election District 52 meeting in Albany on March 5 th and 6 th . ED 52 is a coalition of retiree councils from throughout most of New York State. Its purpose is to discuss NYSUT's services to retirees and to bring items of retiree importance to our state organization. Items that were discussed centered primarily around health insurance coverage but also included discussion of retiree issues that will be on the agenda at the NYSUT convention in May. It was clear that NYSUT leadership is in the loop with the retirees, as shown by the fact that one of the things for which we have advocated, hiring a health insurance expert, has been realized. NYSUT now has on staff an expert whose job is to advise locals negotiating health insurance clauses, including protecting health insurance in negotiations.



New York State United Teachers is being nationally recognized as the number one organization across the country for its contributions to the American Cancer Society's 2023 Making Strides Against Breast Cancer campaign. The statewide union had 174 teams from every corner of New York participating in Making Strides events this past year. Together, they raised \$612,787 to save lives and fund the future of cancer research, patient support and advocacy. Among the thousands of NYSUT members and staff who took part in the annual breast cancer movement, the top five local fundraising team come from NYSUT's Nassau regional staff office, Brooklyn, Staten Island, Buffalo and Westchester. "We are thrilled to surpass our ambitious goal and we know every dollar raised helps defeat this deadly disease," said J. Philippe Abraham, NYSUT secretary-treasurer, whose office coordinates the statewide union's social justice initiatives and who lost one of his sisters to the disease. "Our members' generosity and dedication to community service is part of the fabric of our union. NYSUT is proud to do our part in finding a cure for our educators, their students, families and communities who are impacted by breast cancer, "NYSUT is a flagship sponsor of the annual Making Strides events and has raised over \$17.5 million for the cause since 2002.
