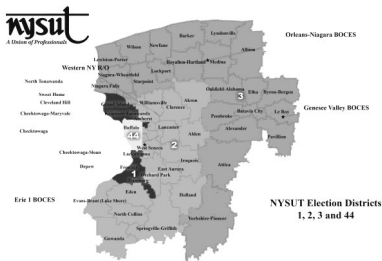

TIME TO GET OUT AND ABOUT

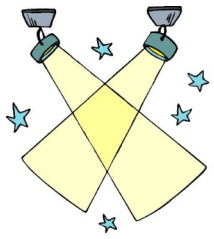

A life-long WNY resident, Liz grew up in West Seneca. She graduated from Buffalo State College with a Bachelor’s degree in Education—earning dual certification in Elementary and Special Education. Her Master’s degree was also in Special Education. She feels fortunate that she was able to obtain a teaching job in the district she went to school in—West Seneca Central SD. Aside from her professional involvement, Liz is a Community Service-Volunteer at FeedMore WNY for the Back-Pack Program which assists students by providing easily prepared, nutritious foods in take-home bags each Friday and throughout the summer. She also volunteers at the West Seneca Schools Clothes Closet and at Elderwood Assisted Living Facility doing crafts activities for the residents.

Liz has been married to her husband Bob for 43 years. They have two children and 4 grandchildren. Her hobbies and interests include traveling with her husband, spending time with her family, reading, craft projects, sewing, cooking and baking—she loves the time retirement allows to try new recipes!
