NYSUT UNITED DEC. 7, 2023: HORSEHEADS SUPPORT STAFF ASSOCIATION ORGANIZED

NYSUT helped a group of nearly 40 school social workers, social work assistants, occupational therapists and physical therapists in the Horseheads School District organize in August after a nearly year-long struggle. For decades the members were part of the Horseheads Support Staff Association, a catchall group of 10-, 11- and 12-month employees that encompassed 21 different job titles and negotiated contracts but wasn't a real union. It didn't hold officer elections or union meetings and the school superintendent appointed its president. After initial resistance, the Horseheads School board voted unanimously in August to recognize the <u>Horseheads Support Staff Association</u> as its newest bargaining unit. Physical therapist **Alisha Tenbus** spearheaded the organizing effort with the help of NYSUT Organizer **Liz Smith-Rossiter** and Southern Tier Regional Staff Director **Tim O'Brien**.

RC #46 Board and Officers send our best wishes and congratulations to this new group of NYSUT members. Some of us were previously, as Inservice members of Horseheads Teachers and Support Staff, involved with these fine employees who faced a difficult situation. We are glad to welcome them into the NYSUT family and look forward to future involvement with their members. SRPS LAUD PASSING OF SECTION 80

Signed by **Governor Hochul** on November 21, New York State SRP Recognition Day, the legislative package will strengthen the rights of SRPs and other public sector workers. One of the changes will amend Section 80 of the civil service law, closing certain loopholes to ensure that union members enjoy the same rights as everyone else. SRPs have been lobbying for this change since the 1990s.

The amendment means that all competitive and non-competitive employees are entitled to the same layoff and job recall protections, ensuring fairer treatment of SRPs.

Congratulations to all SRPs—at long last there is recognition of your value. We thank all at NYSUT who persevered and were able to change legislative attitudes and right a wrong. Next step is to increase your involvement with NYSUT's Retiree Council #46!

CALLING ON ALL CONCERNED RETIREES!

We are entering a period where we must make some tough, informed, and serious decisions based on what is important to us. The political season is starting to go into full swing. As for our families and friends some areas of interest and concern, in no order of importance, include student debt, a woman's right to control her personal health care, fair and free elections, global warming, etc. More importantly is the need to preserve the various structures of our democratic republic created and built by the Founders! As plans are formulated, we may be seeking volunteers to do any or all the following:

- Write postcards, make phone calls, send text messages attend meetings, rallies, and/or town halls, talk to
 your local representatives, or engage neighbors and/or families in discussions, etc. If you do none of the
 above, we ask that you at least do the research and fact checking on those whose names appear on the
 November ballot.
- Decide what topics are important to you and seek information about those issues from any candidate you
 are considering.
- Ask yourself if you know what the position of the candidate you support is on our democratic institutions and structures? Do you know if they support free and fair elections and the peaceful transfer of power from one administration to the other? How do they feel about maintaining your access to a good, affordable Medicare program and Social Security? What is their stance on the pension you receive—is it an earned benefit or an entitlement? Do they believe that we need to address the concerns and conditions of our weather based on climate change/global warming? Does the person believe in a woman's right to decide what her personal health care should be? Is the student debt bore by today's college graduates a concern that needs to be addressed? Is our democratic republic worth fighting to keep? Immigration is a much more difficult topic to solve—is your candidate willing to work to resolve those problems in a mutually beneficial way? Are you getting your background candidate information from a reliable, unbiased source which presents various points of view? Are you on the alert for misinformation and/or can you sort that information into facts versus opinions?

We are a diverse group with diverse opinions-my goal is not to persuade anyone of one position or another. My goal is to encourage careful thought and consideration. The present world we live in has many who are
