One month later we were hit with a mortar attack. Three members of my squad were killed. They were not old enough to vote, but they could die for their country. I will never forget that they were not able to vote, and I will never understand why people don't vote.

Please, if you or anyone you know is not registered, register, and encourage others to register. Remember those who gave their lives to have a country with democratic voting rights AND PLEASE VOTE!

FIX TIER SIX

Please join in this fight by clicking on the "Fix Tier Six" moniker. You can also go directly to this site for guidance fixtier6.org. Help bring fairness to new hires as they find themselves starting a career under this draconian alteration of pension benefits. We are facing problems with filling positions and retaining staff after they choose this career.

Suddenly there is the realization that this decision comes with a diminished pension where you must work longer, pay more into your pension and for a longer period than any other tier and why would those entering the world of work stay in the educational field? We retirees dedicated our hearts and souls to our profession and now must stand

Retiring at 55 with 30 years, would only receive 26.4 percent of his Final Average Salary — after paying tens of thousands more into the system.

Can't retire and collect his pension, without facing heavy penalties, until he's 63



Retiring at 55 with 30 years, would receive 60 percent of her Final Average Salary.

Can retire and collect her pension, penalty free, with 30 years of service at 55 years old.

From **Melinda Person**, NYSUT President:

Why it matters: Whether you're a Tier 5 or 6 member, an earlier pension tier member, a retired educator, a state or local employee who's a non-educator, or you just believe that public employees deserve the dignity of a pension, we must stand in solidarity with Tiers 5 and 6 members. Pension fairness for one means pension fairness for all.

Tier 5 and 6 members deserve better: Paying more and getting less isn't fair, dignified or much of an incentive for our newer members to stay in the teaching profession.

Supporting our professions: If we want to solve the teacher shortage, we need to Fix Tiers 5 and 6. We can't expect newer educators to stay in the field if they must work longer, pay more, and get less in retirement than generations before them. Fixing Tiers 5 and 6 is about solidarity and fairness.

Stand together. We need the collective power of every NYSUT member and public education advocate to get this done. It's time to come together and do the right thing. Together, we can Fix Tier 6!

COMMITTEE OF 100 REPORT

Three of us (**Peter Gordon**, **Jim Jacobus**, and **Cathie Jacobus**) participated in the Committee of 100 (which is closer to including 500 participants—it has grown over the years!) March 4-5. It began with a briefing on the 4th and an early morning arrival in the capitol on the 5th. We lobbied Senator **Tom O'Mara**, Assemblyman **Phil Palmesano**, and Assemblyman **Chris Friend** and discussed the impact of the political decisions they will be making in this year's budget and other legislative actions. The strength of this visit lies with providing them factual and true to life effects of how local school districts are impacted by the choices made in Albany. At the top of the list was the reduction in the foundation aide presented in Governor **Kathy Huchul's** budget. This has decimated many of the small rural districts as well as taken a bite out of programs in larger districts. All legislators assured us that they will fight to restore that essential foundation aide. Fix Tier 6 was also discussed, and they understand that the future of hiring educators is at risk. The pay will never equal the level of importance but a healthy, defined pension often is an incentive to choose and then remain in that position. We need the legislators to undertake this course correction as soon as possible as the crisis will only intensify. Teacher Center funding, APPR for evaluation purposes, Charter schools drain on funding, and the property tax cap were also topics of discussion. Generally, there seemed to be a cooperative atmosphere and we hope to see them "walk the talk." Vote Cope money is used to finance this event so if you do not already contribute, please consider doing so—pension deduction is an easy way to do so! If you do contribute you might consider raising it even if just a bit—we all know that like everything else in this world everything costs a bit more.
